ALSO, I UNDERSTAND THAT YOUTHS VOLUNTEERING AT HILL COUNTRY DAILY BREAD MINISTRIES ARE WORKING IN A WAREHOUSE ENVIRONMENT WITH INHERENT RISKS. STRICT ADHERENCE TO WAREHOUSE RULES WILL APPLY. I AGREE TO RELEASE TO THE FULL EXTENT PERMITTED BY LAW, HILL COUNTRY DAILY BREAD MINISTRIES AND ITS AGENTS, SERVANTS, CONTRACTORS AND EMPLOYEES FROM ALL CLAIM AND DEMANDS OF EVERY KIND OF, OR RESULTING FROM AN ACCIDENT OR DAMAGE TO PROPERTY OR INJURY OR DEATH TO VOLUNTEER WHILE UNDERTAKING VOLUNTEER WORK WITH HILL COUNTRY DAILY BREAD MINISTRIES.
